

**ORDINANCE RECORD****VILLAGE OF NEWBURGH HEIGHTS, OHIO****ORDINANCE NO. 2021-28****INTRODUCED BY:** Mayor Elkins

**AN ORDINANCE AUTHORIZING THE VILLAGE TO ACCEPT AN OHIO DEPARTMENT OF PUBLIC SAFETY EMS 2021-2022 TRAINING AND EQUIPMENT GRANT IN THE AMOUNT OF \$2,632.78, AND DECLARING AN EMERGENCY.**

WHEREAS, the Village has been awarded an Ohio Department of Public Safety EMS 2021-2022 Training and Equipment grant in the amount of \$2,632.78;

WHEREAS, the Village intends to utilize these funds for the purchase of EMS equipment from July of 2021 through December 31, 2021;

WHEREAS, the Village must expend any and all grant funds hereunder by December 31, 2021, and must submit final reimbursement requests no later than January 31, 2022;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEWBURGH HEIGHTS, CUYAHOGA COUNTY, OHIO, at least two-thirds of all the members elected thereto concurring, that:

Section 1. The Village Council hereby authorizes the Village to accept the Ohio Department of Public Safety EMS 2021-2022 Training and Equipment grant in the amount of \$2,632.78, pursuant to the Notice of Contract Award, a copy of which is attached hereto as Exhibit A and which is incorporated herein by reference as if fully rewritten.

Section 2. Council further authorizes the Mayor and/or his designee to make any and all expenditures of said grant funds no later than December 31, 2021, and to take any and all steps to receive reimbursement for said expenditures through January 31, 2022.


Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in such formal action occurred in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the Village, so that the Village can make EMS equipment purchases under this grant as soon as possible;


wherefore, this resolution shall be in full force and effect from and immediately after its adoption and approval by the Mayor.
