ORDINANCE NO. 2021-38

INTRODUCED BY: Mayor Trevor Elkins

AN ORDINANCE AUTHORIZING THE VILLAGE TO RENEW ITS VISION HEALTH INSURANCE BENEFIT PLAN WITH ANTHEM BLUE CROSS & BLUE SHIELD, AND DECLARING AN EMERGENCY.

WHEREAS, the Village wishes to renew its vision health benefits insurance policy, known as Blue View Vision Plan A3, with Anthem Blue Cross & Blue Shield;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEWBURGH HEIGHTS, CUYAHOGA COUNTY, OHIO, at least two-thirds of all the members elected thereto concurring, that:

Section 1. The Village Council hereby authorizes the Mayor to renew its vision health benefits insurance policy, known as Blue View Vision Plan A3, with Anthem Blue Cross & Blue Shield, in the form and at rates specified in the quotation attached hereto as Exhibit A, which is incorporated herein by reference as if fully rewritten.

Section 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in such formal action occurred in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


Section 3. This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the Village, so that the Village can avoid any gap in the vision health insurance benefit provided to certain employees; wherefore, this ordinance shall be in full force and effect from and immediately after its adoption and approval by the Mayor.


