AN ORDINANCE AUTHORIZING THE MAYOR TO RENEW GROUP DENTAL COVERAGE WITH MEDICAL MUTUAL OF OHIO KNOWN AS "MEDICAL MUTUAL DENTAL PLAN 4," AND DECLARING AN EMERGENCY.

WHEREAS, the Village wishes to renew its existing insurance policy for Group Dental Coverage provided by Medical Mutual of Ohio at rates quoted by the Village's insurance broker;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEWBURGH HEIGHTS, CUYAHOGA COUNTY, OHIO, that:


Section 1. The Village Council hereby authorizes the Mayor to renew its Group Dental Coverage with Medical Mutual of Ohio by obtaining Medical Mutual Dental Plan 4 coverage, under the terms set forth in the proposal from Todd Associates and at the rates set forth in Exhibit A hereof, which is incorporated herein by reference as if fully rewritten.

Section 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in such formal action occurred in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


Section 3. This Ordinance is hereby determined to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the Village and its residents, the emergency being the need to continue dental coverage benefits for the Village's full-time employees at reasonable cost. Therefore, provided it receives two-thirds (2/3) of the vote of all members of Council elected thereto, said Ordinance shall be in full force and effect immediately upon its adoption by the Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
