AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH NORTHEAST OHIO TRENCHING SERVICE COMPANY FOR CONSTRUCTION OF THE MULTI-STREET IMPROVEMENTS PROJECT PHASE I (E. 43RD STREET & ALPHA AVENUE) IN AN AMOUNT NOT TO EXCEED \$977,448.50, AND DECLARING AN EMERGENCY

WHEREAS, the Village solicited bids for construction services for the Multi-Street Improvements Project Phase I (E. 43rd Street and Alpha Avenue);

WHEREAS, Northeast Ohio Trenching Service Company submitted a base bid of \$977,448.50, which is within 5.8% of the Engineer's Estimate of Probable Cost and therefore may be accepted; and

WHEREAS, OHM Advisors has recommended that Council accept the bid of Northeast Ohio Trenching Service Company, Council has determined that the lowest and best bid was presented by Northeast Ohio Trenching Service Company, and Council wishes to accept that bid and authorize the Mayor to enter into a contract;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL FOR THE VILLAGE OF NEWBURGH HEIGHTS, COUNTY OF CUYAHOGA AND STATE OF OHIO, THAT:

- Section 1. Council hereby accepts the base bid of Northeast Ohio Trenching Service Company for the Multi-Street Improvements Project Phase I (E. 43rd Street and Alpha Avenue) at a cost not to exceed \$977,448.50, as set forth in the Engineer's Letter of Recommendation, a copy of which is attached hereto as Exhibit A and incorporated herein by reference as if fully rewritten.
- Section 2. Council hereby authorizes the Mayor to enter into a contract with Northeast Ohio Trenching Service Company for the Multi-Street Improvements Project Phase I (E. 43rd Street and Alpha Avenue), in a form approved by the Village Solicitor.
- Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in such formal action occurred in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of public peace, health and safety of the inhabitants of the Village

of Newburgh Heights, such emergency being the need to award the project promptly so that the contractor can obtain materials without delay and at reasonable prices, and begin work as soon as possible; wherefore, provided it receives the affirmative vote of four (4) or more of the members elected or appointed to this Council, this Ordinance shall take effect and be in force immediately upon its passage; otherwise, it shall take effect and be in force from and after the earliest time allowed by law.
