2023 Contractor Registration Instructions

Dear Contractor,

Your 2022 Contractor Registration is expiring. If you plan to work in Newburgh Heights during 2023, you must submit an application, provide a bond, proof of insurance, and where applicable, provide a copy of your State of Ohio License.

Registration certificates and receipts will be mailed unless you provide an email address and indicate that you want your certificate/receipt emailed.

Remember, to be a Registered Contractor in the Village of Newburgh Heights you must provide;

- Provide a bond in the amount of no less than \$10,000.00 (on your insurance company's letterhead with seal) and must at least run through Dec. 31, 2023 (but may extend longer),
- Proof of Liability Insurance in the amount of no less than \$300,000.00 (original certificate is required showing the Village of Newburgh Heights at the Certificate Holder),
- Payment of the annual Contractor Registration Fee in the amount of \$85.00 per application. Checks should be made payable to the Village of Newburgh Heights.
Do not send cash.

Be advised that in addition to being registered with the Village of Newburgh Heights that all required permits must be obtained prior to beginning any work within Newburgh Heights.

Incomplete forms will not be accepted. Complete one for each type of license to be registered.

Registrations will not be processed without payment of fees, bond (\$10,000), and proof of insurance.

Checks made payable to the Village of Newburgh Heights. Credit Card Payments may be made online, over the phone, or in our office. Fees are non-refundable.
