A RESOLUTION NAMING THE VILLAGE OF NEWBURGH HEIGHTS ANNUAL EASTER EGG HUNT, THE DORENE KRAY EASTER EGG HUNT, IN HONOR OF COUNCILWOMAN DORENE KRAY AND DECLARING AN EMERGENCY.

WHEREAS, Dorene Kray became a resident of the Village of Newburgh Heights more than 15 years ago; and shortly thereafter joined Village Council; and

WHEREAS, Councilwoman Kray has served Village Council in numerous capacities and given special care as the Recreation and Seniors Committee Chair, overseeing the implementation of various community events and activities; and

WHEREAS, in 2008 Councilwoman Kray started what would become an Annual Easter Egg Hunt with assistance and financial support from then mayor, Trevor Elkins and Councilmembers Michelle Graora and Steve Moran; and

WHEREAS, she enlisted the assistance of her son and Newburgh Heights resident, Richard Kray, affectionately known as Richie, to serve as the Village's first Easter Bunny – a role he's held since its inception; and

WHEREAS, her dedication as an elected official and public servant in the Village of Newburgh Heights is to be recognized and celebrated during Women's History Month in honor of her selfless work on behalf of the Village and its residents; and

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEWBURGH HEIGHTS, COUNTY OF CUYAHOGA AND STATE OF OHIO THAT


Section 1. The Village's Annual Easter Egg Hunt shall henceforth be known as the "Dorene Kray Easter Egg Hunt," in honor of Councilwoman Dorene Kray and her many years of service and dedication to the Village.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. This Resolution is hereby determined to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the Village and its residents, the emergency being the need to provide assurances to Village employees that they will enjoy the economic benefits of earned vacation time. Therefore, provided it receives two-


thirds (2/3) of the vote of all members of Council elected thereto, said Resolution shall be in full force and effect immediately upon its adoption, otherwise from and after the earliest period allowed by law.
