

**ORDINANCE RECORD****VILLAGE OF NEWBURGH HEIGHTS, OHIO****ORDINANCE NO. 2023-14****INTRODUCED BY:** Mayor Traore**AN ORDINANCE AUTHORIZING THE SALE OF POLICE DEPARTMENT CRUISER 5114 TO CT AUTOMOTIVE FOR THE SUM OF \$1,200, AND DECLARING AN EMERGENCY.**

WHEREAS, Police Department Cruiser 5114 is no longer needed by the Village Police Department and/or is obsolete and no longer necessary for any municipal purpose;

WHEREAS, the Village will realize a discount on certain insurance policy premium if Cruiser 5114 is sold prior to the commencement of the applicable insurance policy period; and

WHEREAS, CT Automotive will purchase Cruiser 5114 for a reasonable price;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF NEWBURGH HEIGHTS, CUYAHOGA COUNTY, OHIO, at least two-thirds of all the members elected thereto concurring, that:

Section 1. Council hereby authorizes the sale of Police Department Cruiser 5114 to CT Automotive for the purchase price of \$1,200.00. Council authorizes the Mayor or her designee to take any and all steps necessary to close the sale authorized herein.

Section 2. Council finds that Police Department Cruiser 5114 is no longer needed by the Village Police Department and/or is obsolete and no longer necessary for any municipal purpose.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in such formal action occurred in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance is hereby determined to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the Village and its residents, the emergency being the need to finalize the sale of the Police Cruiser within a time period that will produce cost savings in connection with Village insurance policy premium. Therefore, provided it receives two-thirds (2/3) of the vote of all members of Council elected thereto, said Ordinance shall be in full force and


effect immediately upon its adoption by the Council, otherwise from and after the earliest period allowed by law.


