AN ORDINANCE AMENDING ORDINANCE 2023-07 TO ADJUST APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF NEWBURGH HEIGHTS THROUGH DECEMBER 31, 2023, AND DECLARING AN EMERGENCY.

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEWBURGH HEIGHTS, COUNTY OF CUYAHOGA, AND STATE OF OHIO:

SECTION 1. THAT TO PROVIDE FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF THE SAID VILLAGE OF NEWBURGH HEIGHTS FOR FISCAL YEAR ENDING DECEMBER 31, 2023, THE APPROPRIATIONS ARE AS FOLLOWS:

SECTION 2. THAT THE VILLAGE FISCAL OFFICER IS HEREBY AUTHORIZED TO DRAW WARRANTS FOR THE PAYMENTS OF ANY FOREGOING APPROPRIATIONS UPON RECEIVING PROPER CERTIFICATE AND VOUCHERS THEREFORE, APPROVED BY THE BOARD OF OFFICERS AUTHORIZED BY LAW TO APPROVE SAME OR AN ORDINANCE OR RESOLUTION BY COUNCIL TO MAKE THE EXPENDITURES; PROVIDED THAT NO WARRANTS SHALL BE DRAWN OR PAID FOR SALARIES OR WAGES TO PERSONS EMPLOYED BY THE AUTHORITY OF AND IN ACCORDANCE WITH THE LAW OR ORDINANCE. PROVIDED, FURTHER THAT THE APPROPRIATION OF CONTINGENCIES CAN ONLY BE EXPENDED UPON APPEAL OF TWO-THIRDS VOTE OF COUNCIL FOR ITEMS OF EXPENSE CONSTITUTING A LEGAL OBLIGATION AGAINST THE SPECIFIC APPROPRIATION HEREIN MADE.

SECTION 3. THAT THIS ORDINANCE IS HEREBY DECLARED TO BE AN EMERGENCY MEASURE IN THAT THE SAME PROVIDES FOR THE IMMEDIATE PRESERVATION OF THE SAFETY AND WELFARE OF THE VILLAGE OF NEWBURGH HEIGHTS, OHIO, AND FOR THE FURTHER REASON THAT THE SAME AFFECTS DAY TO DAY BUSINESS OF THE MUNICIPALITY, AND PROVIDES IT RECEIVES THE AFFIRMATIVE VOTE OF TWO-THIRDS OF THE MEMBERS OF COUNCIL; OTHERWISE, IT SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER THE EARLIEST PERIOD ALLOWED BY LAW.
